CERTIFICATE OF GUARANTEE

FLAG S.p.A.
PVC Flagpool liner
guarantee lasts 10 years starting from
the date indicated on the bill of transport.

The guarantee will have effect provided that:

- The installation and/or setting is performed by companies and/or people acknowledged by FLAG S.p.A.
- The waterproofing system is installed following the minimum prescriptions suggested by Flag S.p.A. according to the application of Flagpool synthetic membranes.
- The materials supplied by FLAG S.p.A. have been paid.
- All components of the waterproofing system have been approved by FLAG S.p.A.

Exclusion

The guarantee does not cover:

1. any damage deriving from missing or insufficient maintenance of the product, set by personnel in charge of the application or interested in the application of the liner;
2. any damage deriving from wrong chemical treatments of water in contact with Flagpool liners;
3. any damage deriving from wrong cleaning procedures of the surface (abrasion, chemical aggressions, etc.);
4. any kind of damage and damages caused by anything, resulting from atmosphere pollution, pollution, infiltration of contaminated waters;
5. any damage caused by wrong setting;
6. any damage caused by chemical-physical interactions with non complying supports;
7. any damage deriving from technical-application solutions adopted on purpose by the Client and not authorised by Flag S.p.A.;
8. any and all expenses supported in extrajudicial settings for researches or investigations aiming at establishing the damage causes, except that the aforesaid researches, investigations or expenses have been previously authorised by the Company;
9. any damage deriving from negligence, accident or wrong use of the Flagpool liner;
10. use of accessories not authorised by Flag S.p.A. and repair performed with materials not branded by Flag S.p.A. or non complying materials;
11. any damage deriving from the presence of chemical substances in contact with Flag S.p.A. products non complying with them and not prescribed when designing the waterproofing system.

Other conditions:

12. this guarantee is issued for the Client when the materials supplied by Flag Spa are installed and the beneficiary is the Customer. It cannot be expanded, nor it can be assigned or transferred by the latter to any other party, provided prior and written approval by Flag S.p.A., any charge deriving from this should be charged to the original Customer;
13. any guarantee obligation by Flag S.p.A. decays as soon as one or more invoices imputable to the material supply or its installation have not been fully paid to Flag S.p.A. (supply) or to Flag s.p.A. authorised Installation Company (supply and setting);
14. this guarantee is governed in compliance with the Italian laws in force and the Customers accept being subject to the Italian jurisdiction exclusively.

Damages claim

The damage claim should be communicated to FLAG spa by registered mail within 3 days from the occurrence, under penalty of the decadence of any right deriving from this insurance. – Via Industriale dell'Isola, 3 – 24040 Chignolo d'Isola (BG).
